(Craft, Antiques, Commercial)

August 6-7-8, 2009 will be the Farmersburg "Old Settlers" Festival at the new town park called "George Heap Memorial Park" and Marshals Field (map enclosed). **Reservations are made in order of response.** Please return your application with your personal check, cashiers check or money order (non-refundable) made payable to Farmersburg Festival, Inc. by July 31, 2009 to the address above. After that date you will be notified by a confirmation letter, e-mail(if available) or a telephone call.

The **Nonfood spaces will be approx. 15' with 3' between the next space at a charge of \$30** for 3 days or \$20 per day. You must provide your own extension cord. You must provide your own tables or display. There will be ample lighting. **We reserve the right to restrict items sold (such as fireworks, Silly String like products, weapons such as swords and knives).** You must be set up and your private vehicle moved by 5 pm (Thurs. - Fri.), or 8:30 am (Sat).

The booth exhibit **MUST** contain only those items listed and/or shown in the photograph submitted with your application. Exhibitors who display items not indicated on their application may be asked to remove the item(s) and/or ultimately asked to leave the show if not removed immediately.

According to the Indiana State Fire Marshal's Office, canopies less than 400 sq. ft. and tents less than 200 sq. ft. with no open flame do not fall under the fire codes. A representative from the State Fire Marshal's Office will be on hand to inspect vendor set-ups.

**Enclosed** are the rules to which you must comply to be part of the Farmersburg Old Settlers.

Please enclose (1) photo representing your set-up, if possible. Photo will be returned at the time of set-up, upon request. Application must be signed and dated, along with a brief description of the type of item(s) you will be selling.
